

Terms and conditions

Applicants are obligated to follow the rules of organization and course payment. The Vienna Music Academy reserves the right to change programs. Participants are provided with practice rooms for individual work. Participants are required to bring their own instruments (except pianists), if not, they are responsible for any renting costs. The application is considered finished when the full course fee is received.

All controversies arising from this contract, a non-compliance, violation or negation of it, are subject to Austrian legislation, court of Vienna. Personal information will not be passed on to third parties and is used solely for organizational purposes for the master classes, courses and seminars of the Vienna Music Academy.

1. Course fees

Fee for master class „Intense“ 585,- Euro

Fee for master classes 555,- Euro

Fee for amateur courses 555,- Euro

Fee for one seminar 530,- Euro

Fee for crash course 250,-Euro

The application is considered valid as soon as the administrative charge of EUR 35 is received. A confirmation of this payment is to be sent via e-mail together with the application form. The filled out form and payment confirmation have to be sent not later than one month before course beginning. Official invitation for the participant will be sent only on receiving payment confirmation for the administrative charges.

2. Application deadline

Deadline for application with existing visa: 20 work days before course beginning

Deadline for application via tour agency: one month before departure.

3. Cancelling

The administrative charge is not part of the course fees and will not be refunded.

A full refund of the master class fee and administrative charge is granted if the master class is cancelled by the organization. A ten percent cancellation fee will be kept if the participant cancels within application deadlines. No fees will be refunded after the application deadline.
